



## Orvis Find Your Wild Holiday Sweepstakes Official Rules

### 1. How to Enter:

The sweepstakes begins at 12:00:01 a.m. Eastern Daylight Time (“ET”) on November 3, and ends at 11:59:59 p.m. ET on December 29, 2016 (“Promotion Period”). To enter during the Promotion Period, sign up on <http://www.orvis.com/holidaysweeps>. After submitting your email address, you will automatically be entered for a chance to win.

### 2. Eligibility:

Open and offered only to legal residents of the 50 United States and District of Columbia who have reached the age of majority in their states as of the start of the Promotion Period. Employees and directors of The Orvis Company, Inc.
